



Rules and Regulations Agreement

1. There is to be **NO** use of alcoholic or tobacco products on the campground.
2. There is to be **NO** admittance to the Utility Barn located near the driveway unless obtaining Frisbee Golf equipment. There is to be **NO** admittance to the utility room in the bathhouse unless turning on/off outside lights.
3. Any maintenance problems must be reported to a contact listed next to the phone in the hall outside the kitchen.
4. **DO NOT** use the dishwasher in the kitchen unless you have been trained by a member of the Camp JYC Ministry Team. (please request training prior to check-in)
5. **NO** long distance calls are to be made. This is a free phone for local calls only. A calling card must be used in order to dial long distance. There is adequate cell phone coverage at the campground.
6. Posted pool rules **must** be obeyed at all times. Do **NOT** remove furniture from the pool area. There is to be **NO** swimming after dusk or diving into the pool. Camp JYC does **NOT** provide a lifeguard during rental group use. If there is not a certified lifeguard on duty then children 16 years of age and under must be supervised by a parent or guardian or similar adult who is responsible for their safety and behavior while at the pool. Adequate lifesaving tools are located in the shed at the end of the pool deck except for the backboard in the nurse's office.
7. **ALL** fires must be built in designated campfire rings only. These are located in the amphitheater behind the pool, near the driveway/parking area, and at the pond.
8. All groups using the grounds for a children's camp (16 years of age and under) must check with the Cattaraugus County Health Department in Olean, NY about their regulations. Any groups using the grounds for a children's camp (16 years of age and under) for more than 72 hours must provide the First Baptist Church of Franklinville with a copy of their Written Safety Plan.
9. **NO** driving past the green bathhouse towards the cabin areas.
10. Posted pond rules **must** be obeyed at all times. There is to be **NO** swimming in the pond. Anyone riding in a boat **must** wear a life jacket. When fishing, the pond is a catch and release pond.
11. **For Emergencies:** Call 911. Camp JYC's address is listed next to phone. All other important phone numbers are listed by the camp phone in the hall outside the kitchen. Another phone is located inside the nurse's office. Report any emergency to the First Baptist Church within 24 hours.
12. **NO** Automated External Defibrillator (AED) on site. When necessary, you must provide your own.
13. **For Emergencies:** such as lost person, fire, or medical; ring the bell continuously until all members of the party are accounted for and give directions for evacuations or other procedures unless a revised plan has been developed by the organization and given to the members of the party.
14. Fire Extinguishers are located in each cabin, both sides of the bathhouse, in the kitchen near the stack oven, and in the lodge near the fireplace. All Fire Extinguishers are mounted on the wall near eye level where they shall remain unless needed for an emergency. If needed, take from wall, pull pin, squeeze trigger and aim at the bottom or source of the fire. Do **NOT** allow children to play with a fire extinguisher.
15. Any group using Camp JYC may participate in activities including but not limited to: cooking, cleaning, boating, swimming, hiking, and use of the athletic fields and courts, etc according to the rules given here. Anyone participating in these activities will do so at their own risk.

Organizations (whether church family or not) not abiding by these rules and regulations may forfeit their right to reserve the facilities in the future and/or face penalties.

A member of the Camp JYC Ministry Team has reviewed these rules and regulations with me and I accept the responsibility to see that my organization is oriented and abides by these rules and regulations.
